CVTEC Visits— L. LaPier's March visit (Update provided by R.Vincent) — March 19 — Morgan, my fourmonth-old Labrador Retriever, and I had the opportunity to visit CVES in the animal husbandry classes. There were two classes taught by Erin Meyer, one in the morning and one in the afternoon. Morgan was fearful of the

large group of adults at first and didn't warm up to greet them individually until the hour was almost over. In the afternoon, she pranced in as if she owned the facility.

I spoke about the importance of researching a breed before adopting or purchasing a dog. Check grooming requirements, exercise level, size, whether the breed gets along well with young children, and health histories of the breed. We discussed how to house train a puppy with positive reinforcement and Morgan was able to "show off" some of her obedience training. It was obvious to the class that puppies are like sponges that soak up training quickly. Time commitment for a puppy was also touched upon and the class was surprised to learn that puppies must be taken outside after waking from many naps they take during the day, after eating, the first thing in the morning and the last thing at night.

Even though the classes enjoyed the demonstration and ensuing discussion, Morgan was the recipient of the most valuable experience. Socialization for puppies is of primary importance to help them accept their environment and this experience was a definite plus for her!
