

Agility Report for November 2016 – Equipment was moved to the barn from the LaPier field on Saturday October 29, 2016. Thank you to JoLee Yeddo, Karen McCarty, Greg Sherman, Linda McGovern, Janet Puhalla and Brenda Lokey for their help moving the equipment.

Thank you to Linda and Rodney LaPier and Robin Magee for the use of their fields for the summer session, as well as Robin Macgee and Karen McCarty for teaching and assisting, respectively, the beginner agility class this summer.

The replacement plank for our teeter has been ordered. Hopefully, by the November meeting it will be installed and ready to go. Thank you to the club for allowing the purchase. Thank you also to Greg Sherman for loaning a small dog walk for use at the barn this winter so that we can use two different contact obstacles.

Registration for the winter session went out mid-October. There are two sessions being offered this winter: a teacher-led session and a self-facilitated session. Thank you to Roxanne Vincent for preparing and collecting registration. The winter session began on November 5, 2016 and we are currently two weeks into the program. We will continue Saturdays throughout the winter, except for Christmas Eve and New Year's Eve.

The scholarship committee, consisting of 3 members and 1 alternate, will screen the applicants and accompanying documents and select the recipient, who receives a reimbursement (in two installments) towards his or her studies.

This change was motioned to approve by L. Moffa. Seconded by B. Heins. All in favor, motion carried.

**Welcome: V. Siskavich** – No Welcome packages sent out at this time.

**Review of Provisional Member Applications:** No new provisional memberships to review at this time.

**Old Business:**

**Donations to Community**– K.McCarty provided detailed information on Elmore's SNIP program and Tail an Treat 4H Dog Club in regards to donations. V. Bechard also had some ideas that differed from the Elmore and 4H suggestions. Motion to table this discussion until the February and to invite V. Bechard to present was made by L. LaPier. Seconded by B. Heins. All in favor, motion carried.

**Website** – D. Pepin is looking for some assistance to finalize the launch of the new website. R. Vincent and V. Siskavich to meet with D. Pepin and push to complete by the next board meeting. V. Siskavich to look at links and we will launch after the board reviews the site at the February Board Meeting.

**Handbook** – With the Agility Committee presenting a revision to their section of the handbook, L. LaPier and R. Vincent will visit each committee and schematically update a couple of committees for the handbook each month. V. Siskavich to update the October 2016 revision with the agility information for the next board meeting.

**New Business:**

**Registration for Classes** – L. LaPier would like send out a mass email prior to the next round of registration to the membership outlining exactly what is expected. There seems to be a lot of chasing of paperwork, vaccination certificates, payment if utilizing a certificate, etc. that can be avoided. Also mentioned was the opening of the forms after the registration has closed. Discussions were made to cut off the ability to keep adding to the classes after the registration deadline. The issue arose with not being able to

keep the classes full so an exception would be for the puppy class. The board agreed to L. LaPier's email and that we should abide strictly to the registration deadlines. That if people are looking to get into class after registration closes they will be placed on a wait list for the next session. Motion made by B. Heins to send out the registration expectation email. Seconded by K. McCarty. All in favor, motion carried.

**Donations for Bereavement** – discussion over how does the club handling donation for bereavement and determine how best to handle. After much discussion, it was decided that it would be done on a case by case basis at this point. Motion to accept was made by L. Moffa. Seconded by B. Heins. All in favor, motioned carried.
